2a. Tom Smith reported that NPSEC is transitioning the organizational structure from an ad-hoc SWAT Team to a formal Board of Directors, effective January 1, 2018. The board structure will include eight PSEP coordinators (or representatives of PSEP programs), two registrants, and one liaison each from AAPSE, APSCRO, and AAPCO. A SWAT Team meeting will be held December 12<sup>th</sup>.

2b. NPSEC has not been officially awarded the EPA Field Meetings Implementation Grant, but has been working with Jeanne Kasai with EPA to develop a budget to hold three meetings in 2018: PACT and two CTAG meetings. Once the budget is finalized, NPSEC will receive an award letter from EPA.
